**Note A: As at 1 April 2013, our Pre-IPO Share Option Scheme had 85,168,706 stock options outstanding. During the month of March 2013, 500,000 stock options were exercised and 768,413 stock options were forfeited. As at 30 April 2013, our Pre-IPO Share Option Scheme had 83,900,293 stock options outstanding, of which stock options were 79,306,863 vested (766,667 stock options vested in the month of April 2013) and available for exercise into Class “A” common shares on a 1 for 1 basis.**

**Note B: As at 1 April 2013, our Post-IPO Share Option Scheme had 66,590,755 stock options outstanding. During the month of April 2013, 5,326,701 stock options were granted and 4,050,000 stock options were forfeited. As at 30 April 2013, our Post-IPO Share Option Scheme had 67,867,456 stock options outstanding, of which 11,644,885 stock options were vested (Nil stock options vested in the month of April 2013) and available for exercise into Class “A” common shares on a 1 for 1 basis.**

**Note C: According to the conversion schedule disclosed in the audited financial statements for the year ended 31 December 2012 (note 12), the total Class “G” and Class “H” preferred shares were available at a conversion rate of 62% based on the vesting terms at April 30, 2013. During the month of April 2013, 6,400,000 vested Class “G” preferred shares were converted into 3,968,000 Class “A” common shares and Nil Class “G” preferred shares were forfeited. The ending balance of Class “G” and Class “H” preferred shares outstanding as at 30 April 2013 was 52,490,000 and 22,200,000, respectively, which if converted, would result in the issuance of a total of 46,307,800 Class “A” common shares (32,543,800 if converted from Class “G” preferred shares and 13,764,000 if converted from Class “H” preferred shares).**
